Narrative Text: 2022-10079 offense report documented by Ptl. Sweely On 4/1/2022 around 9:00AM I met with Hillside Elementary School principal Dr. Brieann Madden. Last night Dr. Madden forwarded me emails she received from the Hillside School PTO (parent-teacher organization) president Heidi Bourke and wanted to discuss this matter further. The emails came from Joseph Fabozzi. Mr. Fabozzi has sent several emails since the beginning of March 2022 to Mrs. Bourke and other members of the Hillside PTO. The basis for Mr. Fabozzi's emails is calling for the removal of Jennifer Olland from the PTO. Ms. Olland is a member of the PTO and has two children attending Hillside School. On 2/4/2022 I was notified by Dr. Madden they called the NJ child abuse hotline in regards to an allegation of sexual abuse see my incident 2022-3862. One of Ms. Olland's children reported to a Hillside staff member they were inappropriately touched by Joe Fabozzi. Mr. Fabozzi is a friend of Joe Dunnkosky, who is the father of the two children attending Hillside. The alleged sexual contact reportedly occurred while the children were visiting their father. It has been reported Ms. Olland and Mr. Dunnkosky are separated. The NJ Division of Child Protection and Permanency (CP&P) investigated the abuse claim and determined it was unfounded. Mr. Fabozzi had attached a letter from the State of New Jersey Department of Children and Families in his email to the PTO. Mr. Fabozzi's communication with the Hillside PTO is claiming Ms. Olland coached her daughter to say he sexually abused her. Dr. Madden and Hillside PTO have not responded to Mr. Fabozzi's emails. This morning around 8:54AM Joe Fabozzi called Hillside School and left a voice message for Dr. Madden. I listened to the message where the caller identified himself as Joe Fabozzi. Mr. Fabozzi indicated he was going to sue the school and needed a teachers name. Mr. Fabozzi used vulgar language in his message stating to the effect that the school is a 'fucking disgrace'. He wanted the teachers name who he believes explained to Ms. Olland's daughter what finger banging is. Dr. Madden was alarmed and concerned Mr. Fabozzi may show up at this school or go to her residence. I discussed this matter with the Superintendent Dr. George Rafferty. Both Dr. Rafferty and Dr. Madden requested I contact Mr. Fabozzi to advise him to cease all communication with principal Madden, Hillside school staff, and all members of the PTO. Around 10:30AM I contacted Joe Fabozzi from the complaint room telephone. He was advised to cease all communication with Hillside school staff and all members of the PTO. Mr. Fabozzi asked if he could attend a board of education meeting. I advised him I would get a definitive answer from the Superintendent of Schools and call him back. A second phone call was placed to Mr. Fabozzi from the complaint room. I advised him since the board of education meetings are usually open to the public, he could attend but cautioned him against making allegations of mis-conduct against any staff or parent. Those accusations would not be permitted during public comments. Mr. Fabozzi verbally indicated he would not contact the school, staff, or parents. He also said he would not go to any meetings. Dr. Rafferty and Dr. Madden were advised of same. Both phone calls from the complaint room were downloaded and submitted as evidence for this case. Fabozzi's voice message to Hillside School was copied to a CD-R and submitted as evidence. Copies of Fabozzi's emails were printed out and submitted to the case
