Narrative Text: Hein #193 BWC On March 17, 2022, at 1757 hours, I was dispatched to [REDACTED] a caller wishing to report a harassment. Upon my arrival, officers spoke with Jennifer Olland, [REDACTED] Fabozzi had been making negative Facebook posts towards her approximately two hours prior to the dispatch. These posts included pictures of her with captions stating that her accusations of child abuse were false. Ms. Olland advised that Mr. Fabozzi also signed a citizens complaint against her in Ocean County for falsifying police reports. Ms. Olland reported she has also seen Mr. Fabozzi parked outside her residence approximately three times. Ms. Olland was advised of the criminal complaint process for Harassment and advised she would respond to Mount Laurel Police Headquarters at a later date to complete a citizens complaint. Additionally, she was told that if Mr. Fabozzi returns to the residence to contact Mount Laurel Police Department. The screenshots of the Facebook posts were forwarded to the case file. Mr. Faboozi indicated that he wanted to file a complaint against Ms. Jennifer Olland, for making a false report to DCP & P of an allegation of child abuse reported against him. Mr. Fabozzi said that the incident occurred in Mount Laurel. Mr. Fabozzi said that he had tried to file a complaint before with Mount Laurel PD and was turned away. Mr. Fabozzi was explained the complaint process and advised to respond to MLPD, complete a citizens complaint form and an officer would have him sign the complaint once it was completed. He was also asked to bring in any proof of the allegations to help his case. No further actions were taken. rev127
